**Please read the following guidelines carefully before submitting an abstract.
Abstracts that do not comply with these instructions will not be reviewed.**

You are kindly invited to submit abstracts on research that you wish to present as a free paper during the symposium, either orally or as a poster.

Abstracts must be submitted via the **abstract submission system** on the **Abstract Submission page** of the **MRS website**. Only **TWO** abstracts can be submitted from with one MSPP-MRS 2024 Symposium's registration fee.

All submissions will be evaluated by assigned reviewers and the scientific committee, who will select abstracts for oral or poster presentation. Case reports can only be submitted as poster presentation. Abstracts not selected for oral presentation will be re-assigned for poster presentation.

Abstracts must be submitted no later than **30th of June 2024**.

Notification of acceptance (oral or poster) will be given by **22nd of July 2024**.

Guidelines

1. Presenting authors must register and **make full payment** for the MSPP-MRS 2024 before their abstracts can proceed for review.
2. Abstracts must be submitted in English.
3. Abstracts must not be more than **300** words (**excluding** of title and author(s) name).
4. Abstracts on case series, case reports, reviews or original research are all eligible for submission.
5. Abstracts can cover any topic that falls under clinical or non-clinical medicine. Please select a topic that in your opinion best fits your work:
 - Clinical Medicine
 - Basic Medical Sciences
 - Public Health
 - Medical Education



6. The abstract of original research should be structured. The structured abstracts should have the following headings:
 - Introduction (the text must be brief and relate the purpose of the study)
 - Materials and Methods (selection of study subjects or experimental animals, observational and analytical methods)
 - Results (provide specific data with their statistical significance, when it is available)
 - Conclusion (must be succinct whilst emphasizing new and important aspects of the study)
7. Abstracts for case reports can be unstructured.
8. Abstracts should not contain references.
9. Single space all text and do not leave blank lines.
10. Place a special or unusual abbreviation in parentheses after the full word the first time it appears. Use generic names of drugs and write numbers as numerals rather than words.
11. Avoid symbol in the abstract.
12. Tables and figures must not be included in the abstract.
13. Please provide a minimum of two (2) and a maximum of five (5) keywords or short phrases that will assist in cross-indexing the article using appropriate terms from MeSH.
14. Abstracts that do not conform with the above guidelines will not be reviewed.

Example of abstract

Donec varius metus justo, ut dictum tellus blandit nec. **Results:** Donec condimentum luctus metus vel condimentum. Suspendisse aliquet, tellus sed dignissim maximus, lacus dolor gravida ipsum, vel semper nulla est non sapien. Suspendisse varius ante a massa efficitur elementum. Pellentesque faucibus ullamcorper euismod. Phasellus egestas mattis justo eu dapibus. Sed lobortis, eros id iaculis gravida, mauris mauris consequat libero, eget imperdiet ante sem id magna. Phasellus at cursus odio, quis tristique nibh. Sed in massa consequat, dignissim erat vel, cursus nisl. Nullam non egestas turpis, quis porttitor eros. Cras sagittis sapien eu lacus tempus posuere. Nullam rhoncus pellentesque nisi ut imperdiet. Pellentesque



habitant morbi tristisque senectus et netus et malesuada fames ac turpis egestas. Donec eros sem, auctor ac tempus et, congue in ligula. **Conclusion:** Sed at viverra nunc, at aliquet ante. Aenean aliquet, eros eget malesuada tristisque, neque magna gravida purus, non ornare libero erat vehicula quam. Fusce non euismod neque. Quisque lobortis maximus dui, non tincidunt ante blandit non.
